Monthly Stamp Club Benefits and Commitment

Overview:

Monthly Stamp Club Members agree to place a minimum \$35 order (merchandise total, before tax and shipping, after any discounts are applied) each month of their commitment (including their HOST month). In return, Club Members rotate receiving HOST benefits, so that each member receives benefits during one month of their 6-month commitment period. {Host Benefits at this level would be at least \$21 in catalog product dollars for each HOST during his/her designated month.} Members will be assigned to club rotations on a first-come, first-served basis; those unable to be assigned to a group of 6 may request to be placed on a waitlist, where they can receive most of the Stamp Club benefits, with the exception of the HOST Benefits.

Details and Additional Benefits:

Monthly Stamp Club Members will receive* a FREE Stampin' Up![®] Annual Catalog current to their commitment period; Members will also receive* any FREE Seasonal or Promotional Catalog applicable to the commitment period, as these publications become available. Each Member will HOST once during their commitment period; and during the month as HOST will receive all Stampin' Rewards Benefits offered by Stampin' Up![®], based on the order totals for that month. One HOST will be assigned to each month during the commitment, randomly by the Demonstrator. Club Members also receive special birthday recognition during their birthday month, a FREE monthly Product-Based Class, a discounted Monthly Technique Class, SNAIL Adhesive and Refills, and other unpublished perks at Demonstrator's discretion.

Optional Stamp Club Sessions (Technique Class) will be offered monthly at a nominal supply fee to Club Members, payable online to reserve your seat. These sessions will be held at Demonstrator's home in Colorado Springs, and members MUST RSVP by the announced deadline date to guarantee seating. Non-Club Member guests may attend a Stamp Club Session, subject to space available. Cost for Non-Members is either \$15 (payable to the Demonstrator and not applied to Stamp Club sales), or it is reduced to the \$3 supply fee with a \$35 Stamp Club Order made by the guest at or before the Club Session, using the Monthly Stamp Club Host Code. If a Club Member RSVPs for a Session but does not attend, the \$3 class fee will be applied towards mailing* the consumables to the Member as a Class Kit to Go. This means you can be a Monthly Stamp Club Member even if you are not local! Class Kits to Go for Club Sessions are reserved for Members only. In addition, a Digital ONLY Class Kit (PDFs and a video of the projects) will be emailed FREE to ALL Monthly Stamp Club Members regardless of whether they pay for a Club Session. Non-Member Guests may buy a Digital ONLY Class Kit after attending a Club Session, but the complimentary copy is Members-only.

Stamp Club Sessions will include two or three projects, in addition to at least one hands-on Technique practice, with the type/theme to be decided at Demonstrator's discretion. Members who pay the \$3 fee will receive all the consumable supplies to make the planned projects. Limited numbers of Paper Snips and Bone Folders will be available at Demonstrator's home, so you may want to bring your own (labeled) supplies to save wait time. Specialty glues are provided by Demonstrator (to include Mini Glue Dots, Stampin' Dimensionals, Tear & Tape, Fine Tip Glue Pen, Tombow Multipurpose Liquid Glue), and glue sticks are provided as a basic adhesive. If you prefer a different basic adhesive, please bring your own, or ask Demonstrator about purchasing discounted SNAIL Adhesive or Refills at the class (subject to availability).

Please Remember: The other members of your Club are depending on your minimum order every month. If you cannot place an order in any given month, you are still responsible for the charges (see contract). At the end of your Club commitment, you may elect to rejoin for the next Club commitment period. If you have fulfilled all the terms satisfactorily (as determined by the Demonstrator), you will be offered first choice of renewal above those waitlisted.
